Association  
Newsletter, March 1989.**

Dear Fellow Member,

In the style of my predecessor in office I should perhaps call this "an opening shot" or maybe a "convertible sighter", allowing me to claim it only if it hits the bullseye.

First, may I say I am honoured to have been elected Chairman of the Association at A.G.M. I was forced to miss. I was off on a company course at the Leadership Trust at Ross-on-Wye where my appointed "activity" turned out to be sub-aqua canoeing (seven times upside down in the mild rapids at Simmonds Yat in two sessions!). By all reports that was tame in comparison to the A.G.M.

I would like to take this opportunity to clarify one or two points which caused contention at the A.G.M. and to report on others with which I am involved on your behalf :-

Selection

Selection is not determined within the Constitution of the Association. It is right that it is discussed regularly at the A.G.M. and the view of those members attending noted by the Council. If the majority view of "the floor" were to be made binding on the Council, the consequence could be difficulty in electing a Council other than from those eager supporters of a single issue. The alternative open to us is, by having the elections after all other business is transacted, to take nominated individuals' views on the matter into account when voting for the Council which will continue to determine the policy.

The thorny question is that of seeding, whether it be direct selection into a team or seeding/invitation into selection trials. The current format, which this Council will follow, dates back four years to the Council Meeting of 9th June, 1985, and promulgated in a Newsletter on 30th September, 1985, where it was determined :-

- (i) Mini-Games (prone) - top four qualifiers in a selection trial comprising the top ten in the Order of Merit (at a given, pre-notified point) and five by invitation. Selection is by trial only.

The 3-Position version was added later with eight qualifying and four invited to shoot in the trial. In this discipline, only the top two triallists are selected automatically with the third and fourth places being dependent upon attainment of a minimum standard score either in the trials or another recognised shoot.

- (ii) Home Countries - the leading 10 scores in the Championship Aggregate in X and A classes and the leading 5 women in the Championship Aggregate in any class.
- (iii) Other outdoor sub-international matches (Army, Devon, Ulster Games, etc) - selected by the Selection Committee blending experienced shooters in form with the development potential of promising shooters, for whom the sub-international experience would be valuable.
- (iv) The Commonwealth Games are an entirely different matter.

Neither Council nor the Association has the power to select, merely the power to nominate to the Scottish Target Shooting Council. The S.T.S.C. in turn nominates a list in agreed order to the Commonwealth Games Council for Scotland where selection is made. The C.G.C.S. adheres strictly to the criterion of "medal winning potential". Proof of this potential to win medals must also be demonstrated. The C.G.C.S. will be guided by but not bound by nominated lists.

Recognising these factors, this Council proposes to follow precedent and nominate the best small-bore medal prospects, determined principally but not exclusively by performance in the Selection Trials.

- (v) The one indoor match is that against New Zealand, North Island. Eight qualify automatically from the Speedway (A & B) Final while seven are selected on performance in previous matches, the Medal, Speedway, Matchplay League, Daily Record, News of the World and other recognised indoor competitions and open meetings.

Under (i), it was agreed at our last Council Meeting that, in light of the new NSRA classification system which restricts the highest class a shooter may choose to shoot in to B class and requires that promotion to A class must be earned, that the Scotland teams in Home Countries would be the leading 10 in the Championship Aggregate in X, A and B classes.

#### Qualification

Eligibility for membership is defined in the Constitution - Scottish birth or parentage or individuals resident for at least 5 years in Scotland.

Qualification to shoot for Scotland, or in Scottish Championships run under the aegis of the Association, is restricted to those members by birth, parentage or 5 years residence who have not represented internationally, or competed in the Championship of, another country in the previous 3 years. Matches are deemed internationals where they are against other national teams or selections.

Eligibility for selection for Commonwealth Games is a mere six months continuous residence immediately prior, even if the competitor has previously represented another country in the Games. This will also apply to Mini-Games.

#### Commonwealth Games, 1990

The Scottish Target Shooting Council has been offered twelve places in the 1990 team for Auckland, subject to convincing proof that each has the potential to win a medal. That encouraging news should be tempered by knowledge of the fierce "political" row which has erupted among the other sports where, for example, swimming has been offered only five places. The athletes and boxers are also up in arms. A review of the initial allocation must be a possibility.

#### Manor Powis

The project is at the outline planning stage. We have addressed a public meeting where all the local residents, almost to a man, expressed opposition ranging from strong to violent. They have a real concern over the interference by noise, particularly from the Big Bore rifle, and by the close proximity of the road exit to the Manor Powis

cottages. Safety is not a concern except in so far as the Army remain unwilling to declare the 300 metre Big Bore range completely safe from ground ricochets. The meeting was conducted civilly and ended amicably.

The S.T.S.C. Facilities sub-committee is examining a new option for the Big Bore range and should be able to overcome the road exit problem by minor re-routing. We are due to go back to meet representatives of the residents early in March with our amendments. The delay in obtaining clearance to proceed will probably mean that the 1992 Nordic Championships, offered to Manor Powis, will have to be committed to Bisley.

#### Denwood

An exciting project to expand and develop Denwood into a sub-national and super-club rifle and pistol facility has been assembled by the Denwood Range Association. As reported in the Press and Journal, the Scottish Sports Council have pledged cash backing for the £260,000 project and the Bon-Accord Rifle Club are set up to sell their Broomhill Road clubrooms to raise further finance. The project hinges on Aberdeen District Council providing matching financial support. We wish Adam and his team every (and early) success.

#### Federation

The word derives from 'to federate - band together in league for some common purpose; organise on a federal basis' where "federal" means 'of a system of government in which several States (Associations) form a unity but remain independent in internal affairs' or 'comprising an association of largely independent units'.

Many of you may have read Bob Aitken's personal statement on Federation. I was handed a copy at a Facilities Sub-committee meeting on 5th December and was given to understand it was a draft of a proposed letter, inviting prior comment from me as a member of the relevant Working Party. I had earlier written a long and definitive proposal to Bob on 13th September, 1988 - without reply. As his letter had already been sent, I take this opportunity of circulating my comments on it sent to Bob on 6th December :-

"Having read the letter on Federation which you propose to send to all shooters in Scotland I must register my disapproval of it. You do not offer a coherent statement of what is involved and the implied threat in your reference to £1.5 million for facilities is particularly dangerous to our interest.

Its whole tone suggests that you have given up trying to persuade the Council of whatever you want Federation to mean and are appealing past them to the amorphous masses with with some ill-defined concept. As written, it offers confusion rather than clarity. It requires a clear vision of what 'federation' could/should mean to the future of Scottish shooting and a credible list of the real benefits to 'the ordinary Club shooter' to whom you are appealing.

I would suggest that any such questionnaire should first be agreed within the Council and that it should start by identifying (and quantifying) the main problems besetting

our sport. It would then attempt to show how combination, whether by federation or amalgamation or however, would facilitate their solution. Finally, it would define the alternative models, probably the two at the extremes, viz. (i) the single body, fully-absorbed version with the conversion of present governing bodies into technical committees, and (ii) the loose federation of autonomous bodies, roughly akin to today's arrangement, and show how each would operate, what they would cost and how much they could achieve - for shooting and shooters. It is only then valid to invite them to indicate a choice.

I trust you will give consideration to my views and perhaps canvass those of your closer colleagues on Council before firing off."

I realise this may not greatly advance your understanding of the issue. It will perhaps show why progress within the Working Party has been so badly hampered by lack of clear, logical analysis and expression.

It is generally accepted among the shooting bodies that we need to federate in some form, if only to remain in a good standing with the Scottish Sports Council whence much of the pressure is coming. A possible exception is the Clay Pigeon body who have reserved their position until the final structure is clear.

We know from the S.P.A. Newsletter that the Pistol body "are advocating Federation along the lines of equal representation for Rifle, Pistol and Shotgun". They state that they would expect Full-bore, Small-bore and Air Rifle and Pistol to come together as a single Rifle body before federating at national level. These Associations and Clay Pigeon have pointed to the respective numbers of members/participants in reply.

Your Council does not share this obsession with representation. We believe pre-occupation with preserving the so-called autonomy and sovereignty of the present bodies is neither healthy nor constructive. How many marriages founder because of the re-assertion in extreme of "personal autonomy"? Our top priority is to secure agreement on the ultimate shape of the future unity, i.e. a single unified body, working to develop target shooting in Scotland, and then to work out the structural and organisational steps and the timetable to get there. It needs more patience, logic and imagination than have so far been shown.

#### Finance

The funds are in reasonable nick and the Scottish Sports Council have increased their grant aid to £1950 (£1500 in 1988). However, we have framed an active development policy which will call for continued fundraising efforts within the Association. Your help in running or contributing to any of these ventures, e.g. the 200 club, the Sponsored shoot, etc, will be greatly appreciated as will any bright or novel ideas you may wish to suggest to us.

#### Development Programme

The date for the Army Match has been fixed and is included in the Calendar of events later in this Newsletter. Selection will be based

on the Grand Prix Series and on the 3-Position Grand Prix Series plus any other relevant open competitions of a suitable standard.

We also anticipate participating in the Ulster Games, this year sponsored by Gilbeys.

On the coaching front, Anne has only recently reached an agreement with Bill Murray to run a county coaches course in Scotland in September (23-24) and October (8-9). Current county coaches are invited to attend this course as a refresher. Anyone interested in this course should please register their interest with Anne Hamilton (see Calendar of Events) as soon as possible. Previous attempts to run similar courses have failed due to lack of interest or to too late an expression of interest. This course will be recognised by the N.S.R.A. Coaches Licensing Scheme.

The members of your Council all look forward to the coming season and to meeting as many members as possible. We are elected to represent your views and interests and can do so far better if you will take a little time to discuss them with us.

**IMPORTANT NOTES ON THE PROGRAMME FOR 1989.  
PLEASE READ CAREFULLY.**

Competitions marked with an asterisk (\*) form the first basis for obtaining a place in the Mini-Games Trials in August. The leading ten competitors in the Grand Prix Order of Merit after 3 Grand Prix meetings and the leading eight competitors in the 3-Position Grand Prix Order of Merit will be invited to the Trials. Other triallists, 5 in the prone trial and 4 in the 3-Position trial, will be invited by the Selection Committee.

The Selection Committee for this year comprises R Normand, AM Hamilton, CG DeJonckheere, K Anderson and BA Duncan.

U.I.T. rules will be applied as in 1988 at all Grand Prix, at the 3-Position Championship Final, at all 3-Position Grand Prix and at the Mini-Games Trials. The latest U.I.T. Rules changes as described in the January 1989 U.I.T. Journal and in the February 1989 Rifleman will not be applied to S.S.R.A. competitions until 1990 allowing shooters one year of grace to modify equipment and clothing where necessary. All members with any queries are most cordially invited to raise them, preferably with the item in question, at the equipment control station at the above events or with the Secretary.

The 3-Positions Championship Final, the Grand Prix Series, the 3-Position Grand Prix Series and the Mini-Games Trials will all be fired on the new targets. The new targets may be used in the qualifying competitions at Grand Prix at the discretion of the organiser.

Drug control may be carried out at any of the S.S.R.A. Grand Prix Series meetings, 3-Position Grand Prix Series meetings, the Mini-Games Trials or any other of its events which the SSRA Council deems appropriate.

**Drug Abuse and the card**

Every member should have received, with his membership card, a small credit card sized aide memoire from the Scottish Sports Council.

This card is part of a scheme being promoted by the Scottish Sports Council to help guide sportsmen in avoiding the use of banned substances, knowingly or otherwise. This scheme was instigated following the incidents at the Olympic Games where both deliberate and unintentional cases of drug abuse were given high exposure in the media and brought sport in general into some disrepute.

The onus is on the individual to beware what he takes. Besides stating clearly the major classes of banned substances, the card also gives a brief guide to proprietary medicines which are not banned. On a card this size the lists cannot be definitive but do indicate preparations which may be used for the most common ailments.

If anyone has any queries on any preparations they may be taking or are considering taking, they should contact the Secretary who will refer their query to the National Drug Control Centre.

## Training Squad 1988-89

The Training Squad has met 4 times this winter, at Meadowbank on December 4th and on January 22nd, at Linwood on 12th February and again at Meadowbank for a two day session on the 4th and 5th of March.

The first two sessions addressed basics with Cyril DeJonckheere looking after the prone members of the Squad and with Anne Hamilton and Cliff Ogle the 3-P.

Having been unable to obtain a February booking at Meadowbank, the squad moved to Linwood where the weather proved exceptionally mild for the time of year but muddy (gratitude is obsequiously expressed to those equipped with wellies who put out the wind flags), and squad members trained outdoors. The opportunity was also taken by the prone group to try air rifle on Linwood's 10 metre range.

The March session, originally planned as a Sunday at Meadowbank rapidly underwent a transformation when Alister Allan and Bill Murray found, unfortunately at rather short notice, that they were free of other commitments and able to come to Edinburgh. Meadowbank kindly rearranged their maintenance schedule to allow us the use of the 50 metres range on the Saturday in addition to the Sunday.

There was concern about the numbers Alister, Bill and the regular coaches could cope with, with only six firing points, but after some planning and scheduling, it was decided that numbers could be increased to include some additional juniors and team members, so invitations were made by telephone. The Treasurer has yet to see the Secretary's phone bill. It was great to see a number of young shooters and a coach from Caithness and Aberdeenshire making it to the session, even if one vehicle did cause its occupants to turn back for an alternative mode of transport.

The final total was 25 shooters and the weekend was slightly hectic but everyone was coached by Alister on the range and in the workshop sessions and also by Bill on the range, in addition to discussion/class sessions with Alister.

Thanks go most sincerely to Edinburgh members of the training squad who provided overnight accommodation for everyone who couldn't make it home for the night and to Shirley and Willie and Bill for hosting a pizza feast on Saturday evening.

Here's the best bit. Alister hopes to be able to spend more time coaching, particularly juniors and 3-P, and to make further visits to our squad. We'll do our best to keep you posted.

## Borrow A Changer Scheme

The S.S.R.A. has a number of U.I.T. Target Changers which are available on loan to groups of members from Scotland teams or the training squad provided a number of conditions are met.

- The changer must be insured against loss or damage.
- The changer must be stored somewhere secure and weatherproof when not in use.
- The changer must be maintained in good condition and working order.
- The changer must be returned in good condition and working order to Linwood when required for Association use.
- The borrower(s) will provide all necessary transport.

- The borrower(s) will bear the cost of any repairs or replacements not covered by insurance.

Some sets of fanfold targets can also be made available with the changers, although borrowers would be required either to provide their own patches for these targets or to provide further sets of targets.

All applications will be considered by Council and should be made in writing to the Secretary (address in Calendar of events).

In short, we were well and truly cuffed. As in the 1987 match, Scotland were left behind at the starting blocks, although sound performances came from new team members BA Duncan and CIH Thomson and also ironically from first time reserves DAM McIntosh and D Hume.

The match analysis above shows teams in score order with differences between individual team members in column D, and the same accumulated in column SD. The negative numbers all the way down column SD mean we were never ahead.

We are now two down in the series. Roll on the 1989 match and better things to come, we hope.

## 1989 Speedway Final

The 1989 Speedway Final was shot at Perth C & C on Sunday 12th March and produced high scores, exciting group matches and a breathtaking finish.

Cliff Ogle went into the last group two points ahead of Hugh Simpson to falter with a 97 on his second target to allow Hugh to draw level on 27 points after all group matches were complete.

On the first targets trying to break the tie, both Hugh and Cliff produced possibles which left the gauge well and truly in its rest. In the second tie break, Hugh allowed one shot to wander while Cliff produced his tenth possible of the day.

Double possibles came from Cliff, Hugh, Irvin and Robin. Last year's winner, Tim Kidner had the misfortune to lose three of his group matches against the 200's, but still produced scores which offer

a glimmer of hope for this year's New Zealand (North Island) Match.
